On 8/3/2014, Chief Mills was assigned to the Lodge Lighting Complex located Mendocino County just above Laytonville, CA. While on the assignment Chief Mills served as a Division / Group Supervisor trainee under several Branch and Division chiefs who served as his trainers. Chief Mills supervised the construction of fire lines utilizing bulldozers, excavators, fallers, engine and crew strike teams. Additionally, Chief Mills was assigned as the Structure Defense Group supervisor where he mapped structures and developed and implemented strategies for their protection. The fire eventually encompassed close to 13,000 acres and was assigned over 2000 firefighters.

On 8/1/2014 Battalion Chief Dan Mahoney was dispatched, as a strike team leader trainee, to Siskiyou County (Northern California) for multiple fires caused by dry lightning. He accompanied a strike team leader who acted as a mentor and assisted in his training for the position. In his 2 week assignment, he performed fire suppression activities on the Oregon Gulch, White, Little Deer, and the Beaver Fire (32,000 acres). His duties included coordinating a 5 engine strike team, assigned to numerous duties such as structure defense (protecting homes from the oncoming fire), constructing fire line (removing fuels down to bare soil), mopping up (cooling smoldering materials after the fire has passed), and firing operations (strategically burning fuels to remove them before the fire arrives). The strike team was relieved of its 2 week commitment and arrived home safe on 8/16/2014.

Below is a summary of the US&R Team's activities on Sunday following the Napa Earthquake written by Rick Addicks and Isaac Wilson.

The earthquake occurred at approximately 0315 Sunday morning. A US&R page for availability was sent at approximately 0415 Sunday morning. The US&R page was completed with personnel checking back with roster full at approximately 0815 Sunday morning; no request yet. A US&R page "immediate deployment" occurred at 0918 Sunday morning.

Although the Marin County US&R SWFR Team has been deployed in and out of county and out of state, and the general US&R Team has been deployed in county, this was the first non-drill out of county deployment for the general US&R Team. OES US&R Regional Task Force 1 - 28 team members and Task Force Leader (Marin County Fire Sen. Capt. Randy Engler; assisted by BC Jeremey Pierce) assembled at the Civic Center with gear and equipment for deployment to the City of Napa. From call out to driving north took approximately 1.5 hours.

The agencies represented were Ross Valley Fire (Wilson / Addicks), Marin County Fire, Southern Marin Fire, Mill Valley Fire, Tiburon Fire, Larkspur Fire, Novato Fire, Marin DPW, Marin Roads, Marin Municipal WD

The assets that deployed were 2 vans and several pickup trucks, "Tylenol" boom truck, "Compartment Truck" with cutting stations, shoring, breaching, etc. A logistics vehicle with search cameras, equipment and communications, Special Operations Truck with miscellaneous tools and supplies, and 1556 the Marin County Heavy Rescue along with 2 Canine search dogs, with handlers and spotters.

At approximately 1130, RTF-1 arrived in the City of Napa and staged in a parking lot near Fire Station 1, downtown. They then divided into search group, cutting station group, and two rescue squads. Napa had been divided into two branches, geographically north and south. The worst damage was in the southern/downtown area which was designated Branch 1. RTF-1 was assigned to Branch 1. Although there were several compromised buildings, mostly involving unreinforced masonry failures (collapsed and partially collapsed walls and chimneys) and broken exterior glass, as the day progressed it ultimately was determined that none of the hazardous occupancies required searching/shoring (i.e., no life hazard). At approximately 1630, RTF-1 was assigned to evaluate a large structure in Vallejo, but this assignment was cancelled quickly. At 1800, the City of Napa released all out of county resources (including strike teams of engines). RTF-1 returned to the Marin County Civic Center at approximately 1930 and disbanded.
